### **SECTION 2 - HAZARDS IDENTIFICATION**

**Classification of the substance or mixture:** this is personal care, cosmetic product. This product fulfill the requirements of the Regulation on Cosmetic Products 2009/1223/CE. #### **POTENTIAL HEALTH EFFECTS:**

**Eye:** Contact may cause mild, transient irritation. Some redness and/or stinging may occur.

### SECTION 4 - FIRST AID MEASURES

**Eye:** Thorough rinsing for 15-20 minutes of the affected eye with water is recommended. If discomfort or irritation persists, contact a physician.
