## Section 4. First aid measures

### Description of necessary first aid measures

## Section 5. Fire-fighting measures

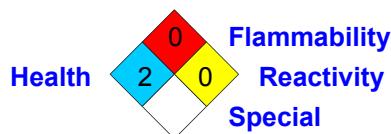
