HAZARD IDENTIFICATION

When used in accordance with the manufacturer's instructions, the product is safe for humans and the environment, in compliance with Regulation (EC) 1272/2008 (CLP).

FIRST AID MEASURES

Contact with the eyes: remove contact lenses if present and rinse carefully with plenty of water; if irritation persists, seek medical advice.

Ingestion: if swallowed, contact the nearest Poison Centre or seek medical advice.

Contact with the skin: there are no contraindication under normal conditions of use. Rinse skin with plenty of water: if irritation persists, seek medical advice.

FIRE-FIGHTING MEASURES

In the event of fire, use water mist, chemical powder, carbon dioxide.

ACCIDENTAL RELEASE MEASURES

Collect the spilled product with sand, sawdust or cloths and transfer to suitable containers for disposal according to regulations. Wash contaminated areas with plenty of water. Never return the spilled product to the original container. Never reuse the spilled product.





HANDLING AND STORAGE

Handling

- Always follow the instructions on the packaging or on the accompanying leaflet, ring or collar.
- Do not use the product for any purpose other than the ones described in the instructions.
- Avoid mixing with other products or similar products or with different substances which are not indicated in the specific instructions.
- Never return the spilled product to the original container for reuse.
- Keep out of the reach of children.

Continuous exposure to cleaning agents (soap, shampoo, liquid detergents) for professional reasons may deplete the hydrolipidic film and horny layer which form the skin's natural barrier. The depletion of this barrier may result in lesions of the skin, which is then more exposed to external agents.

In such conditions, handling other products normally used during professional activities without the necessary precautions (e.g. gloves or specific PPE), may cause intolerance which, in the long term, may lead to more severe forms.

Storage

Store in dry, well-ventilated areas (room temperature).

Do not store or use the product in the vicinity of open flames, heat sources, electrical equipment or direct sunlight.

Close containers well after use.
