Water/Aqua/Eau, Decyl Glucoside, Disodium Coco-Glucoside Citrate, Sodium Lauroyl Lactylate, Glyceryl Stearate, Polysorbate 20, Glycerin, PEG-16 Macadamia Glycerides, Cocamidopropyl Betaine, Panthenol, Fragrance/Parfum, Guar Hydroxypropyltrimonium Chloride, Limonene, Phenoxyethanol.
